# Introduction

These rules govern the way that we operate the SRA Compensation Fund. This is a discretionary fund of last resort for making grants to people whose money has been stolen, or has not been accounted for, as a result of the acts or omissions of those regulated by us, and to relieve losses for which firms authorised by us should have had, but did not have, insurance.

It is funded by contributions from individuals and firms authorised by us.

We have provided guidance on the way we operate the fund.

# **Rule 1: Maintenance of and contributions to the Fund**

- 1. The <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> shall establish and maintain a fund for making grants in respect of claims made in accordance with these rules.
- <u>Solicitors [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor]</u>, <u>RELs [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#REL]</u>, <u>RFLs [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#RFL]</u>, <u>recognised bodies</u> [<u>https://www.sra.org.uk/solicitors/standards-regulations/glossary/#recognised-body]</u> and <u>licensed bodies [https://www.sra.org.uk/solicitors/standards-</u>

- 3. Any unpaid contributions may be recovered as a debt due to the SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA].

  - 1. borrow for the purposes of the <u>Fund</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund];
  - charge investments which form part of the <u>Fund</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund] as security for borrowing by the <u>SRA</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] for the purposes of the <u>Fund [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#Fund].</u>

# Rule 2: The object of the Fund

- 2. The <u>Fund [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund]</u> is a discretionary fund of last resort and no <u>person</u> [<u>https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u>has a right to a grant enforceable at law.
- 3. The primary objects of the <u>Fund [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund]</u> are:
  - to replace money which a <u>defaulting practitioner</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner] or a <u>defaulting practitioner's</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner] employee or <u>manager</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager] has misappropriated or otherwise failed to account for; and
  - 2. to relieve losses arising from the civil liability on the part of a <u>defaulting practitioner [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> or a <u>defaulting practitioner's [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> employee or <u>manager [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager]</u> who in accordance with the SRA Indemnity Insurance Rules should have had, but did not have, in place a <u>policy [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#policy]</u> of <u>qualifying insurance [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance]</u>.

#### Rule 3: Grants which may be made from the Fund

- 3. For any grant to be made out of the <u>Fund</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund]\_, an applicant[https://www.sra.org.uk/solicitors/standardsregulations/glossary/#applicant]\_must satisfy the <u>SRA</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]\_that the applicant[https://www.sra.org.uk/solicitors/standardsregulations/glossary/#applicant]\_is eligible in accordance with rule 4 and (save in respect of a grant made under rule 3.4) has suffered or is likely to suffer:
  - loss in consequence of the dishonesty of a <u>defaulting</u> <u>practitioner [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#defaulting-practitioner]</u> or the employee or <u>manager [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#manager]</u> or <u>OWNEr</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#owner] of a <u>defaulting practitioner [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#defaulting-practitioner]</u>; or
  - 2. loss and hardship in consequence of a failure to account for money which has come into the hands of a <u>defaulting practitioner [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> or the employee or <u>manager [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager]</u> or <u>OWNEr</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#owner] of a <u>defaulting practitioner [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u>, which may include the failure by a <u>defaulting practitioner</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner], which may include the failure by a <u>defaulting practitioner</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] is complete work for which the <u>defaulting practitioner [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting practitioner]</u> to complete work for which the <u>defaulting practitioner [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting practitioner]</u> was paid, in the course of an activity of a kind which is part of the usual

3. For the purposes of rule 3.1(b):



- an individual whose dealings have been in a personal capacity with the <u>defaulting practitioner</u> [<u>https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner]</u> and who has suffered or is likely to suffer loss due to a failure to account shall be deemed to have suffered hardship; and
- 2. a body corporate, or an individual whose dealings have been in a business capacity with the <u>defaulting practitioner</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner] and who has suffered or is likely to suffer loss due to a failure to account must provide evidence to satisfy the <u>SRA</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] that it, he or she (the body or individual) has suffered or is likely to suffer hardship.
- 3. The <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant as an interim measure.
- 4. The <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant to alleviate direct losses suffered as a result of the civil liability of a <u>defaulting\_practitioner</u> [<u>https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner] (other than a solicitor [<u>https://www.sra.org.uk/solicitors/standardsregulations/glossary/#solicitor] or REL [<u>https://www.sra.org.uk/solicitors/standardsregulations/glossary/#solicitor] or REL [<u>https://www.sra.org.uk/solicitors/standardsregulations/glossary/#REL]</u> who falls within rule 5.2(b)) or a <u>defaulting</u> <u>practitioner's [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner] employee, manager [<u>https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager]</u>\_Or <u>Owner [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#owner] in</u> circumstances where:</u></u></u></u>

  - 2. the liability of the <u>defaulting practitioner</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner] or the <u>defaulting practitioner's</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner] employee or <u>manager</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager] would have been covered by a <u>policy</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#policy] of <u>qualifying insurance [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#qualifying-insurance];</u> and
  - 3. the loss is not covered by the <u>SIF</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SIF].

# Rule 4: Eligibility for a grant

- 4. A person [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person] is eligible under this rule to apply for a grant out of the <u>Fund</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund] where the person [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person]:
  - 1. is an individual; or
  - 2. at the time the application is made, is a sole trader, <u>partnership [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#partnership]</u>, body corporate, unincorporated association or mutual association with an annual <u>turnover</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#turnover]\_of less than £2 million,

and does not fall within rule 4.2, 4.3(a) or 4.4(a).

- 5. A <u>person [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> is eligible under this rule to apply for a grant in the circumstances set out in rule 3.1(a) if at the time the application is made the <u>person [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> falls within one or more of the following categories:
  - a <u>charity [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#charity]</u> with annual income net of tax in the most recent financial year of less than £2 million; or
  - 2. a <u>trustee [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#trustee]</u> of a trust with an asset value of less than £2 million.
- 4. A <u>person [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> is eligible under this rule to apply for a grant in the circumstances set out in rule 3.1(b) if the <u>person</u>

- 2. has satisfied the <u>SRA [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#SRA]</u> that its beneficiaries have suffered, or are likely to suffer, hardship if a grant is not made.
- 5. The <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may take into account such evidence as it sees fit when determining eligibility under rules 4.1 to 4.4 and may make a broad estimate of any relevant amount.

# **Rule 5: Defaulting practitioners**

- 5. The SRA may only make a grant in respect of acts or omissions of a <u>defaulting\_practitioner[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u>, or of a <u>defaulting</u> <u>practitioner's [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> employee, <u>owner</u> [<u>https://www.sra.org.uk/solicitors/standards-regulations/glossary/#owner]</u> Or <u>manager [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager]</u> as appropriate, which fall within rule 3.
- 6. A <u>defaulting practitioner [https://www.sra.org.uk/solicitors/standards-</u> regulations/glossary/#defaulting-practitioner] means:
  - a <u>solicitor [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor]</u> or an <u>REL</u>
     [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#REL] who at the date of the relevant act or omission was:
    - 1. practising in an <u>authorised body</u> [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#authorised-body]; or
    - 2. practising in a <u>non-commercial body</u> [<u>https://www.sra.org.uk/solicitors/standards-regulations/glossary/#non-commercial-body]</u>;
  - 2. a <u>solicitor [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor]</u> or an <u>REL</u> [<u>https://www.sra.org.uk/solicitors/standards-regulations/glossary/#REL]</u> who at the date of the relevant act or omission:
    - 1. was self-employed and practising in their own name, and not through a trading name or service company;
    - 2. did not employ anyone in connection with the services they provided; and
    - 3. was engaged directly by their clients with their fees payable directly to them;

- Solicitors Regulation Authority
  - an <u>RFL [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#RFL]</u> who is a manager or owner of an authorised body;
  - 4. a <u>recognised body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#recognised-body];</u> Or
  - 5. a <u>licensed body [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#licensed-body]</u>,

and the expressions "defaulting solicitor", "defaulting REL", "defaulting recognised body", "defaulting RFL" and "defaulting licensed body" shall be construed accordingly.

- 7. A grant may be made where, at the date of the relevant act or omission:
  - a <u>defaulting solicitor [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> had no practising certificate in force;
  - the registration of a <u>defaulting REL</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner] or <u>defaulting RFL [https://www.sra.org.uk/solicitors/standardsregulations/glossary/#defaulting-practitioner]</u> had expired or been revoked;
  - 3. the authorisation of a <u>defaulting recognised body</u> [<u>https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> or <u>defaulting licensed body</u> [<u>https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> had been suspended or revoked;

provided that the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> is satisfied that the <u>applicant</u> [<u>https://www.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]</u> Was unaware of the absence of a valid practising certificate or the relevant expiry, suspension or revocation (as the case may be).

- 6. The <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant to a <u>defaulting practitioner</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner] who or which has suffered or is likely to suffer loss by reason of their liability to any client in direct consequence of an act or omission of:
  - 1. in the case of a <u>defaulting solicitor</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner], <u>defaulting REL [https://www.sra.org.uk/solicitors/standards-</u> regulations/glossary/#defaulting-practitioner] or <u>defaulting RFL</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner], any of their employees or any fellow <u>manager</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager];
  - 2. in the case of a <u>defaulting recognised body</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-



practitioner], any of its employees or managers

In Circumstances where, but for the Hability of the <u>defaulting</u> <u>practitioner [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#defaulting-practitioner]</u>, a grant might have been made from the <u>Fund [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#Fund]</u>

- 7. The <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant under this rule by way of a loan upon such terms as the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> specifies.
- 8. The <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant to alleviate a deficiency in a <u>statutory trust</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#statutory-trust] held by the <u>SRA [https://www.sra.org.uk/solicitors/standards-</u> regulations/glossary/#SRA].



8. The <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may make a grant to a <u>person [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#person]</u> where the money would have been due to that <u>person [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#person]</u> but for their claim having been extinguished under rule 8.2 of the SRA Statutory Trust Rules.

#### Rule 8: Interest

- 8. In respect of any grants made under rules 3, 6 or 7 the <u>SRA</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may make a supplementary grant by way of a sum in lieu of lost interest on the loss underlying the principal grant. - 9. Where the application for the principal grant is in respect of a failure to redeem a mortgage, the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may also make a grant in respect of the additional interest accrued to the mortgage account as a result of the <u>defaulting practitioner's [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner]</u> failure to redeem.

- arise solely by reason of professional negligence by a <u>defaulting practitioner [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#defaulting-practitioner]</u>, or the employee or <u>manager [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#manager]</u> of a <u>defaulting practitioner</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner], save as provided for in rule 3.4;
- are indirect or consequential, save where a claim is made for costs of completing or remedying work for which the <u>defaulting</u> <u>practitioner [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#defaulting-practitioner]</u> has been paid, or as otherwise provided for in these rules;
- 3. are, or result from, the trading debts or liabilities of the <u>defaulting practitioner [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner];</u>
- are for interest payable to the <u>applicant</u> [<u>https://www.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]</u>, save where the discretion to make a grant under rule 8 is exercised;
- 5. are suffered by the Legal Aid Agency as a result of making regular payments under the Agency's contracting schemes for civil or criminal work;
- 6. are where the <u>applicant [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]</u>:
  - 1. has been made bankrupt and any grant would vest in the trustee in bankruptcy;
  - 2. has entered into a voluntary arrangement with their creditors and any grant would vest in the administrator of the arrangement; or

The <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may deduct from any grant such amount as it sees fit to represent monies already recovered, or which will or should have been recovered, by the <u>applicant [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#applicant]</u> through other means in respect of the loss.

#### **Rule 15: Apportionment and multi-party issues**

Where the loss has been sustained as a result of the act or omission of more than one party, the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> will consider the role of each party in contributing to the <u>applicant's [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]</u> loss in deciding whether to make a grant and, if so, the amount of any grant.
- 16. In the case of a <u>defaulting licensed body</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner], the <u>SRA [https://www.sra.org.uk/solicitors/standards-</u> regulations/glossary/#SRA] will consider the extent to which the loss is attributable to an act or omission which falls outside the performance of an activity regulated by the <u>SRA</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] in accordance with the terms of the body's licence in deciding whether to make a grant and, if so, the amount of any grant.

# **Rule 16: Application and time limit**

- 16. An <u>applicant [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]</u> must make an application for a grant in the <u>prescribed [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed]</u> form, and within 12 months of the date they first became aware, or should reasonably have become aware, of the loss.
- 17. The <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may extend the 12 month period in rule 16.1 if satisfied that there are circumstances which justify the extension of the time limit.
- 18. The <u>applicant [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]</u> must provide information, documents and evidence requested by the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u>, which may include verification of matters by statement of truth or affidavit. Failure to provide such documentation or to co-operate with the <u>SRA</u> [<u>https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> will be taken into account when determining the merits of the application.

# Rule 17: Notice to defaulting practitioner

The <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may not make a grant unless it has given not less than 8 days' notice to the <u>defaulting\_practitioner</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaultingpractitioner]\_informing them of the nature and value of the application, unless it appears to the <u>SRA [https://www.sra.org.uk/solicitors/standards-</u> regulations/glossary/#SRA]\_that it would not be reasonably practicable to give such notice, or the grant should be made urgently.
- 18. Where the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> has made a grant urgently in accordance with rule 17.1, the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> shall as soon as, and so long as, it is practicable to do so, give notice to the <u>defaulting\_practitioner</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] in the terms set out in rule 17.1 and may (insofar as any failure to give notice before the making of the grant has prejudiced the <u>defaulting\_practitioner[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] waive in whole or in part the <u>Fund's [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund]</u> right of recovery under rule 18 against the <u>defaulting\_practitioner</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner].</u>

- 20. The fact that an application has been rejected does not prevent a further application being submitted provided that material new relevant evidence or information is produced in support of the new application.

# Rule 20: Costs

Where an <u>applicant [https://www.sra.org.uk/solicitors/standards-</u> <u>regulations/glossary/#applicant]</u> intends to or has already instituted proceedings for recovery of their loss and wishes to apply for a grant in respect of the costs of the proceedings, the <u>SRA</u> [<u>https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> will only consider such costs where:
  - 1. they can be shown to be proportionate to the loss and the amount likely to be recovered; or
  - 2. the proceedings were necessary for the making of an application to the <u>Fund [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund]</u>.
- 21. Where a grant is made, the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may consider an application for a further grant in respect of the reasonable costs properly incurred by the <u>applicant [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#applicant]</u> with either their solicitor or other professional adviser, provided that such costs were incurred wholly, necessarily and exclusively in connection with the preparation, submission and proof of the application.
