Introduction

These rules govern the way that we operate the SRA Compensation Fund. This is a discretionary fund of last resort for making grants to people whose money has been stolen, or has not been accounted for, as a result of the acts or omissions of those regulated by us, and to relieve losses for which firms authorised by us should have had, but did not have, insurance.

It is funded by contributions from individuals and firms authorised by us.

We have provided guidance on the way we operate the fund.

Rule 1: Maintenance of and contributions to the Fund

1. The [SRA](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) shall establish and maintain a fund for making grants in respect of claims made in accordance with these rules.
2. [Solicitors](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor), [RELS](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#REL), [RFLS](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#RFL), [recognised bodies](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#recognised-body) and [licensed bodies](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#licensed-body)

3. Any unpaid contributions may be recovered as a debt due to the [SRA](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA].

The [Fund](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund] is a discretionary fund of last resort and no [person](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person] has a right to a grant enforceable at law.
3. The primary objects of the [Fund](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund] are:
 1. to replace money which a [defaulting practitioner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] or a [defaulting practitioner's](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner's) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner's] employee or [manager](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager] has misappropriated or otherwise failed to account for; and

3. For any grant to be made out of the [Fund](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund), an [applicant](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) must satisfy the [SRA](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) that the [applicant](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) is eligible in accordance with rule 4 and (save in respect of a grant made under rule 3.4) has suffered or is likely to suffer:
 1. loss in consequence of the dishonesty of a [defaulting practitioner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) or the employee or [manager](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager) or [owner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#owner) of a [defaulting practitioner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner); or
 2. loss and hardship in consequence of a failure to account for money which has come into the hands of a [defaulting practitioner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) or the employee or [manager](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager) or [owner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#owner) of a [defaulting practitioner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner), which may include the failure by a [defaulting practitioner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) to complete work for which the [defaulting practitioner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) was paid, in the course of an activity of a kind which is part of the usual business of a [defaulting practitioner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) and, in the case of a [defaulting licensed body](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner), the act or default arose in the course of performance of an activity regulated by the [SRA](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) in accordance with the terms of the body's licence.
3. For the purposes of rule 3.1(b):



1. an individual whose dealings have been in a personal capacity with the [defaulting practitioner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] and who has suffered or is likely to suffer loss due to a failure to account shall be deemed to have suffered hardship; and
2. a body corporate, or an individual whose dealings have been in a business capacity with the [defaulting practitioner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] and who has suffered or is likely to suffer loss due to a failure to account must provide evidence to satisfy the [SRA](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] that it, he or she (the body or individual) has suffered or is likely to suffer hardship.
3. The [SRA](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may make a grant as an interim measure.
4. The [SRA](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may make a grant to alleviate direct losses suffered as a result of the civil liability of a [defaulting practitioner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] (other than a [solicitor](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor] or [REL](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#REL) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#REL] who falls within rule 5.2(b)) or a [defaulting practitioner's](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] employee, [manager](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager] or [owner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#owner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#owner] in circumstances where:

Rule 4: Eligibility for a grant

4. A [person](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person) is eligible under this rule to apply for a grant out of the [Fund](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) where the [person](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person):
 1. is an individual; or
 2. at the time the application is made, is a sole trader, [partnership](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#partnership), body corporate, unincorporated association or mutual association with an annual [turnover](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#turnover) of less than £2 million, and does not fall within rule 4.2, 4.3(a) or 4.4(a).
5. A [person](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person) is eligible under this rule to apply for a grant in the circumstances set out in rule 3.1(a) if at the time the application is made the [person](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person) falls within one or more of the following categories:
 1. a [charity](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#charity) with annual income net of tax in the most recent financial year of less than £2 million; or
 2. a [trustee](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#trustee) of a trust with an asset value of less than £2 million.
4. A [person](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person) is eligible under this rule to apply for a grant in the circumstances set out in rule 3.1(b) if the [person](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person):
 1. at the time the application is made falls within one or more of the following categories:
 1. a [charity](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#charity) with annual income net of tax in the most recent financial year of less than £2 million; or
 2. a [trustee](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#trustee) of a trust with an asset value of less than £2 million; and
 2. has satisfied the [SRA](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) that its beneficiaries have suffered, or are likely to suffer, hardship if a grant is not made.
4. A [person](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person) is eligible under this rule to apply for a grant in the circumstances set out in rule 3.1(a) or (b) if the [person](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person):
 1. at the time the application is made falls within one or more of the following categories:



1. a [charity](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#charity) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#charity], with annual income net of tax in the most recent financial year of £2 million or more; or
2. a [trustee](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#trustee) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#trustee] of a trust with an asset value of £2 million or more; and
2. has satisfied the [SRA](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] that its beneficiaries have suffered, or are likely to suffer, hardship if a grant is not made.
5. The [SRA](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may take into account such evidence as it sees fit when determining eligibility under rules 4.1 to 4.4 and may make a broad estimate of any relevant amount.

5. The SRA may only make a grant in respect of acts or omissions of a [defaulting practitioner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner], or of a [defaulting practitioner's](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] employee, [owner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#owner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#owner] or [manager](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager] as appropriate, which fall within rule 3.
6. A [defaulting practitioner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] means:
 1. a [solicitor](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor] or an [REL](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#REL) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#REL] who at the date of the relevant act or omission was:
 1. practising in an [authorised body](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]; or
 2. practising in a [non-commercial body](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#non-commercial-body) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#non-commercial-body];
 2. a [solicitor](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor] or an [REL](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#REL) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#REL] who at the date of the relevant act or omission:
 1. was self-employed and practising in their own name, and not through a trading name or service company;
 2. did not employ anyone in connection with the services they provided; and
 3. was engaged directly by their clients with their fees payable directly to them;



3. an [RFL](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#RFL) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#RFL] who is a manager or owner of an authorised body;
 4. a [recognised body](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#recognised-body) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#recognised-body]; or
 5. a [licensed body](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#licensed-body) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#licensed-body],
- and the expressions "defaulting solicitor", "defaulting REL", "defaulting recognised body", "defaulting RFL" and "defaulting licensed body" shall be construed accordingly.
7. A grant may be made where, at the date of the relevant act or omission:
 1. a [defaulting solicitor](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] had no practising certificate in force;
 2. the registration of a [defaulting REL](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] or [defaulting RFL](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] had expired or been revoked;
 3. the authorisation of a [defaulting recognised body](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] or [defaulting licensed body](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] had been suspended or revoked;provided that the [SRA](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] is satisfied that the [applicant](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#applicant] was unaware of the absence of a valid practising certificate or the relevant expiry, suspension or revocation (as the case may be).

The [SRA](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may make a grant to a [defaulting practitioner](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] who or which has suffered or is likely to suffer loss by reason of their liability to any client in direct consequence of an act or omission of:
 1. in the case of a [defaulting solicitor](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner], [defaulting REL](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] or [defaulting RFL](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner], any of their employees or any fellow [manager](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager) [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#manager];

 1. they can be shown to be proportionate to the loss and the amount likely to be recovered; or
 2. the proceedings were necessary for the making of an application to the [Fund](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [\[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund\]](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Fund).
21. Where a grant is made, the [SRA](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [\[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) may consider an application for a further grant in respect of the reasonable costs properly incurred by the [applicant](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) [\[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#applicant\]](https://www.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) with either their solicitor or other professional adviser, provided that such costs were incurred wholly, necessarily and exclusively in connection with the preparation, submission and proof of the application.
