

Abandonment or sudden closure

If you discover a <u>recognised sole practice</u>

<u>Client [https://www.sra.org.uk/consumers/using-solicitor/legal-jargon-explained#client]</u> money and papers may be at <u>risk [https://www.sra.org.uk/consumers/using-</u> <u>solicitor/legal-jargon-explained#risk]</u>. We may need to take action to protect clients by appointing <u>intervention [https://www.sra.org.uk/consumers/using-</u> <u>solicitor/legal-jargon-explained#intervention]</u> agents to close the practice in a controlled way. They will freeze the firm's accounts and take possession of client papers for safe keeping, which they will then pass on to us, if they cannot return them to you or another legal adviser acting on your behalf.
