Introduction

The Code of Conduct describes the standards of professionalism that we, the SRA, and the public expect of individuals (solicitors, registered European lawyers and registered foreign lawyers) authorised by us to provide legal services.

They apply to conduct and behaviour relating to your practice, and comprise a framework for ethical and competent practice which applies irrespective of your role or the environment or organisation in which you work (subject to the Overseas Rules which apply to your practice overseas); although paragraphs 8.1 to 8.11 apply only when you are providing your services to the public or a section of the public.

Conduct does not need to take place in a workplace in order to relate to your practice – these requirements capture conduct which touches realistically upon your practice of the profession, in a way that is demonstrably relevant.

You must exercise your judgement in applying these standards to the situations you are in and deciding on a course of action, bearing in mind your role and responsibilities, areas of practice, and the nature of your clients (which in an in house context will generally include your employer and may include other persons or groups within or outside your employer organisation).

You are personally accountable for compliance with this Code - and our other regulatory requirements that apply to you - and must always be prepared to justify your decisions and actions.

A serious failure to meet our standards or a serious breach of our regulatory requirements may result in our taking regulatory action against you. A failure or breach may be serious either in isolation or because it comprises a persistent or concerning pattern of behaviour. In addition to the regulatory requirements set by us in our Codes, Principles and our rules and regulations, we directly monitor and enforce the requirements relating to referral fees set out in section 56 of the Legal Aid, Sentencing and Punishment of Offenders Act 2012, and provisions relating to anti money laundering and counter terrorist financing, as set



out in regulations made by the Treasury [http://www.legislation.gov.uk/uksi/2017/692/made] as in force from time to time.

All these requirements are underpinned by our Enforcement Strategy. That strategy explains in more detail our views about the issues we consider to be serious, and our approach to taking regulatory action in the public interest.

This introduction does not form part of the SRA Code of Conduct for Solicitors, RELs and RFLs.

- You do not unfairly discriminate by allowing your personal views to affect your professional relationships and the way in which you provide your services.
- 2. You do not abuse your position by taking unfair advantage of <u>clients</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client] or others.
- 3. You perform all <u>undertakings [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#undertaking]</u> given by you, and do so within an agreed timescale or if no timescale has been agreed then within a reasonable amount of time.
- 4. You do not mislead or attempt to mislead your <u>clients</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client], the <u>court [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#court] or</u> others, either by your own acts or omissions or allowing or being complicit in the acts or omissions of others (including your <u>client [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u>).
- 5. You treat colleagues fairly and with respect. You do not bully or harass them or discriminate unfairly against them. If you are a <a href="mailto:

2. You do not misuse or tamper with evidence or attempt to do so.

- 3. You do not seek to influence the substance of evidence, including generating false evidence or persuading witnesses to change their evidence.
- 4. You do not provide or offer to provide any benefit to witnesses dependent upon the nature of their evidence or the outcome of the case.
- 5. You only make assertions or put forward statements, representations or submissions to the <u>court</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#court] or others which are properly arguable.
- 6. You do not place yourself in contempt of <u>court</u>

 [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#court], and you comply with <u>court [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#court]</u> orders which place obligations on you.

- 8. You draw the court's [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#court] attention to relevant cases and statutory provisions, or procedural irregularities of which you are aware, and which are likely to have a material effect on the outcome of the proceedings.

- 7. Where you supervise or manage others providing legal services:
 - 1. you remain accountable for the work carried out through them; and

- 8. You ensure that the individuals you manage are competent to carry out their role, and keep their professional knowledge and skills, as well as understanding of their legal, ethical and regulatory obligations, up to date.

- 1. <u>clients [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> are informed of any financial or other interest which you or your business or employer has in referring the <u>client [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> to another <u>person</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person]_Or which an <u>introducer [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#introducer]</u> has in referring the <u>client [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> to you;

- 6. You do not act if there is an <u>own interest conflict</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#own-interest-conflict] or a significant risk of such a conflict.
- 7. You do not act in relation to a matter or particular aspect of it if you have a <u>conflict of interest [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#conflict-of-interest]</u> or a significant risk of such a conflict in relation to that matter or aspect of it, unless:
 - 1. the <u>clients [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> have a <u>substantially common interest [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#substantially-common-interest]</u> in relation to the matter or the aspect of it, as appropriate; or
 - 2. the <u>clients [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> are <u>competing for the same objective [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#competing-for-the-same-objective]</u>,

Where you are acting for a <u>client [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> on a matter, you make the <u>client</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client] aware of all information material to the matter of which you have knowledge, except when:
 - 1. the disclosure of the information is prohibited by legal restrictions imposed in the interests of national security or the prevention of crime;
 - 2. your <u>client [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> gives informed consent, given or

- evidenced in writing, to the information not being disclosed to them;
- 3. you have reason to believe that serious physical or mental injury will be caused to your <u>client</u>

 - 1. effective measures have been taken which result in there being no real risk of disclosure of the confidential information; or
 - 2. the current or former <u>client [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> whose information you or your business or employer holds has given informed consent, given or evidenced in writing, to you acting, including to any measures taken to protect their information.

7: Cooperation and accountability

- 7. You keep up to date with and follow the law and regulation governing the way you work.
- 8. You are able to justify your decisions and actions in order to demonstrate compliance with your obligations under the <u>SRA's regulatory arrangements [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#regulatory-arrangements]</u>.
- 9. You cooperate with the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u>, other regulators, ombudsmen, and those bodies with a role overseeing and supervising the delivery of, or investigating concerns in relation to, legal services.
- 10. You respond promptly to the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> and:
 - provide full and accurate explanations, information and documents in response to any request or requirement; and
 - ensure that relevant information which is held by you, or by third parties carrying out functions on your behalf which are critical to the delivery of your legal services, is available for inspection by the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u>.

- 11. You do not attempt to prevent anyone from providing information to the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> or any other body exercising regulatory, supervisory, investigatory or prosecutory functions in the public interest.
- 12. You notify the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> promptly if:
 - 1. you are subject to any criminal charge, conviction or caution, subject to the Rehabilitation of Offenders Act 1974;
 - 2. a <u>relevant insolvency event [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#relevant-insolvency-event]</u> occurs in relation to you; or
 - 3. if you become aware:
 - i. of any material changes to information previously provided to the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u>, by you or on your behalf, about you or your practice, including any change to information recorded in the <u>register</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#register]; and
 - ii. that information provided to the <u>SRA</u>

 by you or on your behalf, about you or your practice is or
 may be false, misleading, incomplete or inaccurate.
- 13. You report promptly to the SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] or another approved regulator [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#approved-regulator], as appropriate, any facts or matters that you reasonably believe are capable of amounting to a serious breach of their regulatory arrangements [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#regulatory-arrangements] by any person [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person] regulated by them (including you).
- 14. Notwithstanding paragraph 7.7, you inform the SRA
 <a href="[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] promptly of any facts or matters that you reasonably believe should be brought to its attention in order that it may investigate whether a serious breach of its regulatory arrangements
 <a href="[https://www.sra.org.uk/solicitors/standards-regulations/glossary/#regulatory-arrangements] has occurred or otherwise exercise its regulatory powers.
- 15. You do not subject any <u>person [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> to detrimental treatment for making or proposing to make a report or providing or proposing to provide information based on a reasonably held belief under paragraph 7.7 or 7.8 above, or paragraph 3.9, 3.10, 9.1(d) or (e) or 9.2(b) or (c) of the SRA Code of Conduct for Firms, irrespective of whether the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> or another approved regulator subsequently investigates or takes any action in relation to the facts or matters in question.

- 16. You act promptly to take any remedial action requested by the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u>. If requested to do so by the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> you investigate whether there have been any serious breaches that should be reported to the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u>.
- 17. You are honest and open with <u>clients</u>

If requested to do so by the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] you investigate whether anyone may have a claim against you, provide the <u>SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> with a report on the outcome of your investigation, and notify relevant persons that they may have such a claim, accordingly.</u></u>
- 18. Any obligation under this section or otherwise to notify, or provide information to, the SRA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] will be satisfied if you provide information to your firm's COLP [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#COLP] or COFA [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#COFA], as and where appropriate, on the understanding that they will do so.

- 8. You ensure that, as appropriate in the circumstances, you either establish and maintain, or participate in, a procedure for handling complaints in relation to the legal services you provide.
- 9. You ensure that <u>clients [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> are informed in writing at the time of engagement about:

- 1. their right to complain to you about your services and your charges;
- 2. how a complaint can be made and to whom; and
- 3. any right they have to make a complaint to the <u>Legal</u> <u>Ombudsman [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Legal-Ombudsman]</u> and when they can make any such complaint.
- 10. You ensure that when <u>clients [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> have made a complaint to you, if this has not been resolved to the <u>client's [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> satisfaction within 8 weeks following the making of a complaint they are informed, in writing:
 - 1. of any right they have to complain to the <u>Legal Ombudsman</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Legal-Ombudsman], the time frame for doing so and full details of how to contact the <u>Legal Ombudsman</u> [https://www.sra.org.uk/solicitors/standards-regulations/glossary/#Legal-Ombudsman]; and
 - 2. if a complaint has been brought and your complaints procedure has been exhausted:
 - 1. that you cannot settle the complaint;

You ensure they are in a position to make informed decisions about the services they need, how their matter will be handled and the options available to them.
- 9.
